Result 1: Thrive Together as Families

Proposed Target: By 2026, increase permanency with “family” for children and youth in the target populations by X# or %.

Data Development Agenda: Need progress indicator and data source for baseline.

- “What is the most doable set of action steps we could take in the fall of 2022 that will move us closer to achieving our stated Results?”
- Identify if any legislative policy changes are needed

Older Youth Work Group

This group could select one or two focal points for its work this fall and early winter. There are several options:

1.1.2 Create an Office of Youth Development by September 2023

- The OYWG had a productive conversation about this strategy that is well documented in the March and May meeting notes. They identified a need for the OYWG/VC to gather information from models in other states, and from key leaders in Iowa, to assist in making a proposal for an Office of Youth Development (the Office) that, potentially, builds on or sharpens up existing efforts. There is acknowledgement that the existing entity, Iowa Collaborative on Youth, could benefit from using the Results Based Accountability/Results Based Facilitation model and that, perhaps, that could be part of the VC’s contribution. It was also acknowledged that there may be value in designing and promoting the Office as a corollary to the Early Childhood Initiative.
 - Recommendation: Pick up on the action planning that was done in May and focus the OYWG’s efforts on getting this priority on track to be completed by the desired due date of September 2023.

1.2.8 Adopt a Crossover Youth Practice Model

- In its March meeting, the OYWG had a good sense of next steps for this 2022 Priority. Depending on what happened with the presentation to the Community-Based Services Group of the Juvenile Justice Task Force (if the presentation has happened), the OYWG may need to go back to near-term action step planning to move this forward. The sense of the OYWG is that this is a viable Priority and that the OYWG/VC could make a significant contribution to this effort.
 - Recommendation: Recruit a OYWG member to run point on this strategy. It could be Kathy Thompson or Kayla Powell, because they serve on the Dual System Youth Work Group for the Juvenile Justice Task Force. But, it could also

be someone else from the OYWG, or someone newly recruited to the OYWG to lead this as a project.

1.2.9 Replicate Iowa's pre-charge-pre-arrest diversion programs statewide for all youth with first-time, simple offenses.

- In April, the OYWG came to the conclusion that its contribution to the pre-charge/pre-arrest diversion program would be to bring the Healing-Centered Engagement model to the existing sites. Initial action commitments were made to begin that integration process.
 - Recommendation: Identify a person to run point on this as a project for the OYWG/VC. This could be a current member of the OYWG or someone could be recruited to join the Work Group who could lead this work.

1.2.6 Adopt and implement a comprehensive family identification and engagement model to prevent unnecessary family separation and support youth and children who are placed into care systems.

- This is a cross-cutting strategy that the OYWG could choose to carry out on behalf of the Vision Council. The identified first step is to do a landscape assessment of what Family Finding Models are effective and in use in other states and to identify who is supportive of bringing Family Finding to Iowa.
 - Recommendation: Identify a OYWG to run point on this strategy on behalf of the Group (Chris Koeplin?)
