      - Not sure how they will help, may be willing to fund webinar
- Planning out the pathway to a Results Action Plan/ARPA recommendations to Director Garcia on 9/24, including:
  - o Deciding how to sequence and assign the work
    - Look at target settings for workgroup
    - Now that we have MCO support, may be able to slow down and work more strategically
  - o Agreeing on a basic timeline
    - Will meet again prior to meeting with Director Garcia

- September
  - Prepare Concrete strategies to propose for ARPA funding
    - Which ARPA financing streams to tap
  - Out of the 6 programming recommendations, agreed on
    - o 1. Caring Community Concierge
    - o 3. Home Visiting Program
      - May require code changes due to people being out of service areas
    - o 6. Helping kids by helping families
    - o Discussion on 4. Recovery Coaching Program
      - Already exists but could be built up better
- Oct/Nov
  - Develop a Results Action Plan that will achieve progress toward identified target

## • Setting a Target for the Program Population

- By 2026, lowa will safely reduce the percent of families with young children (ages 0-10) entering the child welfare system by 50%
  - Members will discuss this further
  - Greg and Kristie will work with DHS to determine number of children entering the child welfare system
    - At intake level? Assessment level? Or Confirmed/Founded cases?
  - Will still plan to cut the number in half
